The Aquatic Facility Operator (AFO) Course is an 2-day training program designed to meet the needs of those working in public and semi-public recreational pool or water park facilities. The AFO Course offers unique discussions on risk management and pool management as well as training in proper water chemistry, water chemistry challenges and solutions.

Upon successful completion of the AFO Course and 50 question open book exam, participants will be certified for 5 years by the National Certification Board in coordination with the National Recreation and Park Association.

Examination

Candidates will have 3 hours to complete an open book examination. Calculators may be used during the examination and exams will be graded on site. Each successful candidate will receive a certificate and wallet card.

Aquatic Directors, Recreation Directors, Water Park Directors, Pool Managers, Aquatic Supervisors, Resort/Hotel/Motel Staff, and any staff member responsible for the operation, maintenance and management of an aquatic facility
