The Aquatic Facility Operator (AFO) Course is an 18-hour training program specifically designed to meet the needs of those working in public and semi-public recreational pool or water park facilities. The AFO program offers unique discussions on risk management not usually directed towards operational personnel as well as training in proper water chemistry, water chemistry challenges and solutions. Upon successful completion of the AFO course and a 50 question open book exam, participants will be officially certified by the National Certification Board of the National Recreation & Parks Association.
