As a committed professional, Pat is very active at the state and national levels having served as President of the Massachusetts Recreation and Park Association in 2005-2006, where she remains on the Board of Directors. She served on the NRPA New England Regional Council for 24 years, serving as the Council Chair from 2005-2006. Additionally she was a member of the NRPA American Parks and Recreation Society Executive Committee from 2008-2010. Pat has served NRPA in myriad ways, to include NRPA National Forum Representative for APRS, NRPA Administrators Network Executive Committee and National Forum Representative. Pat has been an active member of the NRPA Congress Program Committee since 2008.

Her passion for community involvement is evidenced by her service to the Rotary Club of Yarmouth where she has been a member for over 13 years and has served on its Executive Committee and as President.

Working with the Program Committee is really a positive volunteer experience with NRPA. You are required to read and rate over 100 session proposals which is done online at your convenience. Members Travel to the Congress location and meet as a group to discuss the selections which are presented to the committee in ranking order. This occurs over 2 days. NRPA staff prepares all the material during this meeting. Travel and accommodations are the responsibility of the members and NRPA issues each member a free Congress packet for their volunteer service. Great professional experience. Very rewarding. NRPA staff are great to work with also.
