

## National Recreation and Park Association Guardians of Greenspaces Podcast Drawing

### National Recreation and Park Association - Sponsor

**1. Eligibility:** The Guardians of Greenspaces Podcast Drawing (the “Drawing”) is open to those who are representing a public park and recreation staff and or likeminded organizations’ employees. In order to be eligible, an entrant has to respond to NRPA’s Key Takeaway survey within two weeks of a podcast episode releasing on Guardians of Greenspaces. Of the pool of respondents, one winner will be randomly chosen per episode. The winner will receive a free NRPA annual conference registration, valid only for the 2026 NRPA Annual Conference in Philadelphia from September 29 through October 1, 2026, up to a value of \$798. A total of five winners will be chosen during the time period of May 12 to September 22, 2026, with one winner per episode. Limit one entry per person per episode. Additional entries do not increase the chance of winning for each episode. Once an entrant is chosen as a winner, they are no longer eligible to win again for the current contest period. The Drawing is only open to legal residents of the United States who are 18 years of age and older and is void where prohibited by law. The contest is not open to National Recreation and Park Association or Scotts Miracle-Gro officers, board members, employees, or their immediate relatives. “Immediate relatives” includes only parents, siblings and their spouses, and natural or adopted children and grandchildren of the individual or his or her spouse. The Drawing is subject to all applicable federal, state and local laws and regulations. This Drawing is void in any state where prohibited or otherwise restricted by law.

**2. Agreement to Rules:** Participation in this process or selection to receive this award does not constitute an official endorsement or approval by NRPA of any such product, company, or service. **3. Entry Period:** Entries will be accepted starting on or about May 12, 2026, and ending September 30, 2026. All entries must be received by September 22, 2026, 11:59 P.M. EDT.

**4. How to Enter:** You may enter only once, under either method (A) or method (B) below. You may not enter under both methods.

#### **(A) Entry Online**

The Drawing can be entered by submitting an entry using the online form provided on the Drawing webpage (<http://nrpa.org/guardiansofgreenspaces>). The entry must fulfill all Drawing requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the National Recreation and Park Association. You may enter only once per episode, and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to

circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of the National Recreation and Park Association.

### **(B) Entry by Mail**

You do not need to enter online. Any eligible person wishing to participate in the Drawing may submit an Entry Form. Each submitted Entry Form must be a three inch by five-inch piece of paper that contains your name, complete email address, complete postal address, telephone number, and the words "NRPA Drawing". Prizes:** 5 winners representing park and recreation professionals or like-minded staff will receive a free NRPA annual conference registration, valid only for 2026 NRPA Annual Conference in Philadelphia from September 29 through October 1, 2026. No cash or other prize substitution permitted except at the National Recreation and Park Association's discretion. The prize is nontransferable. Any and all prize related expenses, including and without limitation of any and all federal, state, and/or local taxes shall be the sole responsibility of the winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by winners is permitted. Acceptance of a prize constitutes your irrevocable permission for the National Recreation and Park Association to use your name, likeness, and entry for purposes of marketing, advertising and trade without further compensation, unless prohibited by law.

If the selected winner cannot be contacted, is ineligible, fails to

claim the prize within 72 hours from the time award notification was sent, or fails to timely return completed and executed declaration and release forms as required, prize may be forfeited and an alternate winner selected.
