- Must have maintained the CPSI certification for a minimum of 6 years (two certification cycles)
- Must be a current member of NRPA *
- Must be a member of the ASTM F15.29 Subcommittee on Playground Equipment for Public Use *

* Candidate must join and maintain membership in good standing with the NRPA and ASTM F15.29 Subcommittee upon application approval.
