

## 2019 NRPA Annual Conference Sweepstakes Rules and Restrictions:

NO PURCHASE IS NECESSARY TO ENTER OR WIN THE CONTEST. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** Sweepstakes (the “Sweepstakes”) is open only to those who sign up at the online sweepstakes page and who are age 18 as of the date of entry. The sweepstakes is only open to legal residents of the United States and is void where prohibited by law. The contest is not open to National Recreation and Park Association officers, board members, or employees, or their immediate relatives. “Immediate relatives” includes only parents, siblings and their spouses, and natural or adopted children and grandchildren of the individual or his or her spouse. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited.
2. **Agreement to Rules:** By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of the National Recreation and Park Association, as final and binding as it relates to the content. The Sweepstakes is subject to all applicable federal, state and local laws.
3. **Sweepstakes Period:** Entries will be accepted online starting on or about April 1, 2019 and ending May 12, 2019. All online entries must be received by May 12, 2019 11:59PM EST.
4. **How to Enter:** The Sweepstakes must be entered by submitting an entry using the online form here: [www.nrpa.org/conference/registration/sweepstakes](http://www.nrpa.org/conference/registration/sweepstakes). The entry must fulfill all sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the National Recreation and Park Association. **Limit of one (1) entry per person** and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of the National Recreation and Park Association.

5. **Prizes: One (1) grand prize package will be awarded**, which consists of: one (1) 2019 NRPA Annual Conference Registration (including education sessions, exhibit hall daily admission, NRPA opening reception ticket), three (3) nights in a Baltimore hotel, and round-trip airfare provided in partnership with Southwest Airlines. **One (1) second prize will be awarded**, which consists of either one (1) NRPA Live full package registration, admittance to one (1) off-site institute or preconference workshop at the NRPA Annual Conference, or admittance to one (1) active outing or leisure tour at the NRPA Annual Conference. A public vote during the entry period will determine the second prize.
  
6. **Prize Conditions:** The National Recreation and Park Association reserves the right to choose the appropriate registration package, the hotel, and the type of room for the grand prize winner. NRPA will only provide the winner with the option of flying via Southwest Airlines within the United States. To use the flight credit, the winner must fly out of an airport serviced by Southwest and the return flight must go back to the original departure airport. Air transportation by Southwest Airlines Co. is subject to Southwest Airlines' Passenger Contract of Carriage ("Contract of Carriage"), which is available at [www.southwest.com](http://www.southwest.com). Winner will be permitted to book Southwest flights and must provide all flight details to The National Recreation and Park Association who reserves the right to review and approve the flight dates and times. Actual/appraised value may differ at time of prize award. The specifics of the prizes shall be solely determined by the National Recreation and Park Association. No cash or other prize substitution permitted except at the National Recreation and Park Association's discretion. The prizes are nontransferable and the Southwest Airlines e-passes may not be resold. Any and all prize related expenses, including and without limitation of any and all federal, state, and/or local taxes shall be the sole responsibility of the winner. Acceptance of prizes constitutes permission for the National Recreation and Park Association to use winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.
  
7. **Odds:** The odds of winning depend on the number of eligible entries received.
  
8. **Winner selection and notification:** Winners of the Sweepstakes will be selected in a random drawing under the supervision of the National Recreation and Park Association. Winners will be notified via email to the email address they entered the Sweepstakes with within five (5) days following the winner selection. The National Recreation and Park Association shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 15 days from the time award notification was sent, or fails to timely return a completed

and executed declaration and releases as required, prize may be forfeited and an alternate winner selected. The receipt by winner of the prize offered in this Sweepstakes is conditioned upon compliance with any and all federal and state laws and regulations. ANY VIOLATION OF THESE OFFICIAL RULES BY ANY WINNER (AT THE NATIONAL RECREATION AND PARK ASSOCIATION SOLE DISCRETION) WILL RESULT IN SUCH WINNER'S DISQUALIFICATION AS WINNER OF THE SWEEPSTAKES AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.

9. **Rights Granted by you:** By entering this content you understand that the National Recreation and Park Association, anyone acting on behalf of the National Recreation and Park Association, or its respective licensees, successors and assigns will have the right, where permitted by law, without any further notice, review or consent to print, publish, broadcast, distribute, and use, worldwide in any media now known or hereafter in perpetuity and throughout the World, your entry, including, without limitation, the entry and winner's name, portrait, picture, voice, likeness, image or statements about the Sweepstakes, and biographical information as news, publicity or information and for trade, advertising, public relations and promotional purposes without any further compensation.
  
10. **Terms:** The National Recreation and Park Association reserves the right, in its sole discretion to cancel, terminate, modify or suspend the Sweepstakes should (in its sole discretion) a virus, bugs, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Sweepstakes. In such case, the National Recreation and Park Association may select the recipients from all eligible entries received prior to and/or after (if appropriate) the action taken by the National Recreation and Park Association. The National Recreation and Park Association reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Sweepstakes or website or violates these Terms & Conditions. The National Recreation and Park Association has the right, in its sole discretion, to maintain the integrity of the Sweepstakes, to void votes for any reason, including, but not limited to; multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by sweepstakes rules; or the use of bots, macros or scripts or other technical means for entering. Any attempt by an entrant to deliberately damage any web site or undermine the legitimate operation of the sweepstakes may be a violation of criminal and civil laws and should such an attempt be made, the National Recreation and Park Association reserves the right to seek damages from any such person to the fullest extent permitted by law.
