CONTINUING EDUCATION UNIT (CEU) REQUIREMENTS

Continuation of certification shall be contingent upon completion of a minimum of three (3.0) Continuing Education Units or equivalent academic course work from an accredited college or university in each 36-month period. **Note:** Please do not send official documentation of continuing education to NRPA unless you are requested to do so as part of the audit process. The second page of this application must be completed and submitted as proof of your CEU requirement completion. Upon receipt of the recertification application, NRPA will select a random percentage of applications for audit. Certificants who are selected for audit will be directly notified by NRPA. Certificants will have 30 days to submit their continuing education materials for the audit process. Failure to submit the continuing education materials in a timely manner will result in a denial for recertification. If you do not have your required 3.0 CEUs you must re-take the current CPRE exam within your certification cycle.
