LAND AND WATER CONSERVATION FUND

In 1965, the Land and Water Conservation Fund (LWCF) was enacted to help preserve, develop and ensure access to outdoor recreation. The LWCF program has two components: the Federal Land Acquisition Program (Federal Side), and the LWCF State Assistance Program (State Side).

The LWCF State Assistance Program provides funding to local governments for the acquisition and development of public outdoor recreation areas and facilities. In FY17, the **LWCF State Assistance Program provided over \$110 million in funding to states and localities. This included \$12 million going directly to urban areas** through competitive Outdoor Recreation Legacy Partnership (ORLP) grants, which are funded under the LWCF State Assistance Program.

NRPA ASKS CONGRESS TO:

- 1. Fully fund and permanently reauthorize the Land and Water Conservation Fund, which is set to expire on September 30, 2018.
- 2. Ensure robust funding for the LWCF State Assistance Program at 40 percent of overall LWCF allocations, appropriating no less than \$110 million (FY17 level).

LASTING IMPACT ON LOCAL ECONOMIES AND QUALITY OF LIFE

The LWCF State Assistance Program requires states and local communities to match the federal investment dollar-fordollar. Since 1965, the LWCF State Assistance Program has:

• Provided funding to over 40,000 projects, totaling in over \$4 billion going to states, territories and local communities. Combined with the local match, LWCF State Assistance funds have yielded a total investment of more than \$8 billion.

Wise Use of Federal Funds at NO Expense to the U.S. Taxpayer

• The funding for the LWCF State Assistance Program comes not from taxes, but primarily from oil and gas lease revenues derived from federal Outer Continental Shelf (OCS) offshore oil and gas leasing revenues.

Creating Jobs and Stimulating the Economy

The outdoor recreation industry is one of the nation's most important economic drivers. The LWCF State Assistance Program supports our nation's local and regional parks, which **generates nearly \$154 billion in economic activity and support 1.1 million jobs every year** in the United States.

Every State and Territory Receives Funding

States do not have to compete against other states for funding. Each year, a set percentage of LWCF State Assistance funding is equally distributed to the states and territories. Remaining funds are then allocated based on population.

Available To and Used By Every Community

98% of all counties in America have parks and projects funded by the LWCF State Assistance Program. LWCF State Assistance Program projects must remain in recreational use in perpetuity,ensuring that the federal, state and local investments will benefit future generations.
